Apply *Converge Turf* monthly at 5 to 7.5 pounds per 1,000 sq. during a 3-month time period. *Converge Turf* can also be applied as a single application of 15 to 20 pounds per 1,000 sq.

Converge is a fully dispersible granule and for best results, Converge should be watered-in immediately following application.
