LUNAR is easy to use and will not harm turf when used in accordance with product directions. When used as directed, LUNAR can be applied at anytime of the year to prevent the detrimental impact of water repellency stress and localized dry spot on turf and to increase the vigorous appearance of turfgrass.

Greens, Tees, Fairways, Lawns, Parks and Sports Turf

Localized Dry Spot and Water Repellency Conditions: Apply LUNAR as a preventive program. LUNAR should be applied at 4-6 ounces (125 - 180 ml) per 1,000 sq. ft. (100 m²) in 2 gallons (8 L) of water. Reapply every 30 days throughout heat stress period.

It is highly recommended that LUNAR Soil Surfactant be applied at least 30 days prior to the development of environmental conditions that promote plant stress and water repellency on thatch and soil particle surfaces.
