

LUNAR-G is a 30-day preventative soil surfactant formulated to establish consistent water flow into and throughout the rootzone. LUNAR-G is easy to use and will not harm turf when used in accordance with product directions. When used as directed, LUNAR-G can be applied at anytime of the year to prevent the detrimental impact of water repellency stress and localized dry spot on turf and to increase the vigorous appearance of turfgrass.

Localized Dry Spot and Water Repellency Conditions: Apply LUNAR-G as a preventative monthly program. Apply Lunar –G at 2.5 to 3 pounds per 1000 sq. ft. on a monthly program. Irrigation after application is recommended to move the product into the soil profile.

Do not apply Lunar – G to wet turf.
